- ii. Circle of Elders provided consent for the Wild Meat Program.
- iii. The Circle of Elders will be meeting with the Principals in the new school year.
- iv. Request for a report on MESC's COVID response.
- v. Henry will be taking prints to the sundance on behalf of MESC.
- vi. The circle discussed the discovery in Kamloops and how it had impacted Maskwacisak. Would like MESC to present services available to students and staff who may be triggered by this event.
 - 1. Discussion on MESC's response, student supports and trauma informed practices.
 - 2. There are grants available to search for grave sites.
- vii. Request to present the vaccination statistics at the next meeting.
- viii. Will be scheduling an in-person meeting to review the curriculum.
- ix. Could arrange for the Circle of Elders and the Board to meet with the Chiefs annually.
- x. Suggestion to host Circle of Elders events. Provide a platform for the Elders to share knowledge and stories.

a. Wild Meat Program

Workplace accommodations will be made on a case by case basis. There is also sick leave available through EI. Need to ensure messaging is clear.
 - Recommendation to test all staff in the fall.

c. Student and Staff Bursaries
