### a. Jr./Sr. High School Realignment

Presenter: Brian Wildcat and Keith MacQuarrie

### Discussion:

- i. Recommendation to realign the Ermineskin and Samson Jr./Sr. High School programs. Louis Bull and Montana jr. high programs would remain at their schools and realigned in the future.
- ii. Will not be laying off staff.
- iii. Concerns of gang activity in the Samson high school is a common misconception. The school culture has greatly improved.
- iv. Capital plan is being created to ensure facilities can accommodate programming.
- v. Schools would be rebranded.
- vi. Concern that change will negatively impact attendance. Not the right time to move forward with the project during a pandemic.
- vii. Need more engagement with parents.
- viii. Opportunities for programming and bringing students together as Maskwcisak rather than divided.
- ix. Concerns of social issues that impact the schools. The transition may be hard for some students to adjust.
- x. Concern with transportation and ride times.
- xi. Need to secure land to move forward with negotiations for the new high school.
- xii. Administration would host open house events to advertise programming available.
- xiii. Need to communicate with parents more in regard to resources available at all MESC schools.
